
- 2. That the name of the TRUST shall be "RANJIT SAHA EDUCATION TRUST, DHATRIGRAM" having its registered office at office at Choto Swaraj Pur, PO-Dhatrigram PS- Kalna ,Dist- Purba Bardhaman, West Bengal and its another branch office at Katwa Panuhat Paschim Para PO- Panuhat PS-Katwa, Dist, Purba Bardhaman and another branch office may be opened in any other place or places as the trustees may decide from time to time.
- 3. That the objects for which the trust is established are:
 - a) To establish, develop, run, promote, support, and grant aid or other financial, managerial, technical assistance to all kinds of educational institutions like schools, colleges universities, establishment, imparting technical, engineering, medical, management education, vocational training institutions, teachers training institutions, establishment, undertaking, applied/basic scientific researches, socio—economics, researchers / studies for use of the students, staffs and also for the development and advancement of education and diffusion of knowledge amongst the public in general.
 - b) To establish maintain and run hostels, laboratories, libraries, reading rooms, studentship, scholarship and render other kind of aid to students including supply of books, stipend, medals and any other incentives to study without any distinctions as to caste, colour, race, creed or sex.



- c) To promote establish, run, support maintain or grant aid to institutions for the promotion of scientific researches, literature, music, drama, and fine arts for the preservation of historical monuments and for the research and other institution of India having similar objects objects for the benefit of the people in general.
- d) To promote establish, run, support, maintain, or grant aid to home for the aged orphanages, or other establishment for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons.
- e) To promote establish, run and develop programs, projects schemes institutions for the physically handicapped and disabled mentally retired persons and to provide them education food clothing shelter or other help.
- f) To promote, establish, run and run develop programmes, projects, schemes institution for conservation of natural resources including afforestation.
- g) To promote, establish, run, and develop programmes, projects, schemes for rural development including training of persons for implementation of such programs/ projects schemes for rural development.
- h) To promote establish run and develop programs, projects, schemes for awareness and implementation of family planning practices among the people including training of persons for implementation of such programs projects schemes.




- i) To promote, establish, run, and development programmes, projects, schemes for social welfare like promotion of rationalism against superstitions or eradication of aids and any other diseases among the people including training of the persons for implementation of such programmes/projects/schemes.
- j) To grant relief to the needy victims during natural calamities such as famine, earthquake, flood, fire, riot, etc. and to give donation and other assistance to institutions, establishment of persons engaged in such relief work.
- k) To grant, aid, or render assistance to public charitable trust, societies or institutions.
- To establish, run, and develop programmes/projects/schemes awareness of the pollution free society.
- m) To develop tribal society, nutrition and other development for their upliftment.
- 4. That the trust fund may be augmented by the income from the initial fund and also by donation and other contributions from time to time. The income of the Trust Board will be also forms any financial resources from complying the objectives of the trust. The trust fund will be invested as per provision u/s 11(5) of the IT Act, 1961 and amendment up to date.




- 5. That the trust fund shall not be applied or used for any purpose other than those specified in paragraph 3 hereinabove.
- 6. That the trustees shall always maintain proper accounts of the trust which shall be kept at the office/s o the trust. The trust account will be audited by duly qualified auditor as per law.
- 7. That the furtherance of the objects of the trust, the trustees shall have the following powers:
 - a) To accept any donation, contribution, grant or subscription in cash or in kind from any person (s), body of persons, entities o trust from India or abroad with or without conditions.
 - b) To apply the whole or any part of the income of the trust of the trust fund or accumulation thereto, to any one or more of the objects of the trust as the trustees may, in their discretion deem fit from time to time.
 - c) To convert and deal with the trust property and/ or any investment for the time being.
 - d) To invest the trust fund in the purpose of mortgage of immovable property or in the share, stock and debentures or other securities and investments or in deposits with or loans to ay company, bank, firm or any other person and to alter, vary or transpose such investment from time at the discretion of the trustees.

- e) To borrow or raise or secure payments of moneys and also to lend money either with or without security from nationalized or non nationalized financial organizations or body.
- f) To sale dispose off, alienate or otherwise deal with any property comprising the trust fund.
- g) To let out, lease, demise any immovable property comprised in the trust fund for such rent, on such terms and conditions as the trustees in their discretion may think fit.
- h) To open account in the name of the trust, trustees and/or institutions run/conducted by the trust with a bank or banks to operate such accounts and to give instructions to the Bank and to provide for opening and operation of such account by two or more of the trustees or by an agent appointed by the trustees.
- To adjust, settle, compromise, compound referred to the arbitration all actions, suits, claims, demands, and proceedings regarding the trust funds.
- j) To appoint and agents and to delegate such attorneys or agents all or any of the constituted attorneys or agents all or any of the powers vested on them under this presents and from time to time remove such attorneys or agents and to appoint other /s in his or their place.
- k) To appoint or make provisions for the appointment of any person (including all or any of the trustees or

committees or administrators or managing trustees/managing trustees or otherwise) for the purpose of administration for the trust in such manner and subject to such rules and regulations as the trustees may prescribe and also to appoint and provide appointment of separate trustees to hold any fund or investments subject to any provisions of this deed in such manner and subject to such rules and regulation as the trustees may time to time may think fit.

- 1) To make alter or modify schemes, rules and regulations for carrying out the objects of the trust and for the management of the affairs thereof and/or running any institution in further ends of the object the trust and otherwise for giving effect to the object of the trust.
- m) To start, abolish, discontinue, or restart any charity or charitable institutions for the benefit of the general public and to impose any condition to any subscription or donation made by them.
- n) To set apart and /or allocate the whole or a part of the income for the purpose of the trust fund or part thereof for any of the objects of the trust.
- o) To make over, purchase, acquire, manage, control other charitable trust, society, institutions, association or their assets/liabilities or to join, corporate or amalgamate this trust or its assets/liabilities with other or others having similar or allied objects upon such terms and conditions as the trustees may in their discretion think fit,

particularly having regard to and in conformity with the objects and nature of this trust.

- p) To settle all accounts and to compromise, compound abandon or refer to arbitration any action or proceeding or dispute, claim, demand, or thinks as deem proper for such purpose without being responsible for any loss occasioned thereby.
- q) To borrow money either on the security of any property comprised in the trust fund or otherwise for all or any of the purpose of these presents, and it shall be lawful for the trustees to make such borrowings on payment of such interest and otherwise such terms and conditions as they may in their absolute discretion think fit.
- r) To apply to the govt., public bodies, corporations, companies, or any persons from India or abroad, for and to accept grant of money and of aid, donations, gifts, subscriptions and other assistance with a view to promoting the objects of the trust and to discuss and negotiate with the government departments, public and other bodies, corporations, companies and person scheme, project and other work and matters within the objects of the trust and to confirm to any proper conditions upon which such grants and other payments may be made.
- s) To establish, promote, manage, organise or maintain or to assist in establishing, promoting, managing organizing or maintaining any branch of the trust or any



other trust or its branches with objects similar to those of this trust and to promote or carry on the affiliation or amalgamation of such other trust with this trust.

- t) To transfer and hand over this trust to any other society, occupation, institution, trust, or organization on such terms and conditions as the trustees shall in their absolute discretion think fit proper to be held by the society, corporation institution, trust or organization with the declaration. and agreements powers provisions appearing, contempt in this present subjects to such modifications may be as may be necessary consequent such transfer of the trust fund. The trustees of the time being of this presents shall become discharge from the trust hereof relating to the trust funds so transferred.
- 8. The trustees shall be accountable only for such moneys, stocks, shares, and funds as shall actually come into their hands and a trustee shall not be answerable or accountable for neglect, default, acts or omission or commission of the other trustees not of any banker or other person with whom the trust properties or any securities may have been deposited or kept.
 - 9. The trustees will not be entitled to receive any remuneration personally, but the trustees may reimburse themselves all expenses actually incurred by them in connection with the trust or their duties relating thereto.



- 10. The number of the trustees shall not be less than two, and more than twelve. If the number of the trustees fall more than two the remaining trustees shall not, except for the filing up vacancy, act so long the number is below the said minimum. The vacancy of any trustee Members will be filed in by nomination of either the Chairman or the Secretary subject to approval by the existing member s unanimously during the vacancy in the said way, the Chairman or Secretary will have the power to take decision in case of the tie of the meeting of the Board Of The Trustee. No post of any member will remain vacant for more than three months.
 - 11. The settler will hold the chair of president till his death or resignation or termination and other officials like secretary of the trust will be elected in the annual meeting after three years.
- 12. That the members of the trustees while meeting and taking decision and to bring any act jointly will be treated as "Trustee Board".

All meetings of the Trustee Board will be presided over by the President and in his absence by Secretary.



- 13. A person shall be ceases to be a Trustee in the following situations:
 - a) Death.
 - b) Insolvency.
 - c) Resignation subject to acceptance by Trustee Board.
 - d) On being rendered incapable to perform the duties due to old age or continuous illness of the Trustee or Trustees.
 - e) On being convicted of any offence for more than three month involving moral turpitude.
 - f) On failure to attend four consecutive meetings of the Board of Trustee without sufficient cause or without previous intimation.
 - g) On being adjudicated as an insolvent by the competent Court.

- h) On being removed or impeached by the majority members of Board of Trustees.
- 14. That the trustee Board shall meet at least twice a year at a year at the gap of six months in ordinary course. In any occasion, emergency Trustee Board may be called for by the chairman or secretary at any time subject to three days notice to each member including to the business to be transacted or discussed.

That the Quorum of the meeting will be at least four in which either the Chairman or the Secretary is to be present and that the Secretary is to be informed within three days of the emergency meeting about the result of the meeting.

That the proceeding of the Trustee Board meeting is to be recorded in writing either by the Secretary or by the Chairman in a Resolution Book which is be kept in the custody of Chairman or Secretary and the same will be signed by the members present in such meeting. That notwithstanding anything stated hereinbefore or hereinafter the the Chairman and/or the Secretary shall in case of any emergency be authorised to take any decision for emergency affairs and all fulfilling emergency needs. That said decision will however be placed and approved before the trustee Board in its next meeting.

The trustee may time to time frame Rules for the conduct and regulations of the meetings of the Trustee.



- 15. That Trustees shall have the power to determine, in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses out goings ought to be paid or borne and every such determination shall be binding and conclusive Provided that nothing contained shall deemed to be authorise the trustees to spend the income or Corpus of the Trust for any purpose not authorised by the presents.
- That the accounting year of the Trust shall be the financial year ending on 31st March every year.
- 17. That the trust and trust fund shall be irrevocable for all times.
- 18. That the expressly declared that the no part of the Trust Property or its incomes or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not charitable purpose in law, and all the provision thereof shall be consider accordingly.

- That the trusted have no landed property till the execution of the present. Any conveyance, mortgage, reconveyance, lease or any other deed, document or assurance, whatsoever, may be signed, executed, or registered by the President/Chairman and/or of Secretary on behalf of Trust.
- 20. That all other function of the trust will be held accordingly to the provision of the Trust Act.
